

1.0 GENERAL

1.1 INTRODUCTION

This manual presents the Maintenance Instructions for the Airfilm Camera Systems model of the AFM-NM429-1 Nose Utility Mount for the Bell 429 series rotorcraft. The mount is designed to facilitate the attachment of equipment such as video camera, searchlights and infrared sensors. The cover page of this document shows the typical mount installation.

1.2 PURPOSE

The purpose of this document is to provide Maintenance Instructions to inspect the Airfilm Camera Systems Model AFM-NM429-1 Nose Utility Mount

1.3 SCOPE

The scope of this document is limited to information, procedures, requirements and limitations for this Supplemental Type Certificate. When a requirement specified in the appendix to the regulations is not applicable to this Supplemental Type Certificate the requirement will not be included in the Maintenance Instructions.

1.4 APPLICABILITY

These Maintenance Instructions are applicable to the Airfilm Camera Systems AFM-NM429-1 Nose Utility Mount

1.5 DOCUMENT CHANGE CONTROL

Changes to this document will be distributed to registered owners of the within AFM-NM429-1 Nose Utility Mount 10 days after the revision is approved. Changes to this document will be indicated by a revision number in the footer, vertical lines adjacent to the change, and in the Record of Revisions.

1.6 SPECIAL TOOLS

No special tools are required for maintenance of this appliance

2.0 AIRWORTHINESS LIMITATIONS

3.1 SCHEDULED INSPECTIONS

The scheduled inspections required by this document are contained on the following checklists. This checklist, when completed, is to become a permanent part of the AFM-NM429-1 Nose Utility Mount

NOTE: There are no field repairs or overhaul allowed for the AFM-NM4299-1 Nose Utility Mount.

If any component fails the following inspections, the mount is to be removed from the helicopter and returned to Airfilm Camera Systems.

3.1.1 100 HOUR INSPECTION INTERVALS

The 100 hour time in service inspections consist of visually inspecting the critical area of the AFM-NM429-1 Nose Utility Mount

Due to the simplicity of the mount structure, all scheduled 100 hour inspections consist of the same items since the mount is inspected while installed on the helicopter.

The inspections per Table 3.1.1 are required while the AFM-NM429-1 Nose Utility Mount is installed on the helicopter at the time in service interval as specified. The inspection is to be performed by maintenance personnel.

Remove appliance from helicopter in accordance with Section 4.0

3.2 SPECIAL INSPECTIONS

Hard Landing: Inspect for evidence of ground contact or damage.

Remove if indications exist.

3.3 INSPECTION LIMITS

The AFM-NM429-1 Nose Utility Mount is to be removed from service and returned to Airfilm Camera Systems if the following inspection limits are exceeded.

Cracks: Any indication
Bolt hole elongation Any Indication
Corrosion: Any Indication

Dents, scratches, wear or nicks

Greater than 0.015 inches

4.0 REMOVAL, DISASSEMBLY, REASSEMBLY AND INSTALLATION

On initial installation, the AFM-NM429-1 Nose Mount is installed over the Bell Front Landing Light Cover Panel P/N 429-706-017-119 (or 429-706-017-101) with 3M Tape or A2008 Protective Cloth between the panel and the Nose Mount Assembly.

To remove the Nose Mount, remove the Front Landing Light Cover fasteners (Bell P/N 120-225C3T-15). The Nose Mount and Landing Light Cover Panel will come off together. Remove the 3M Tape (or Protective Cloth) from the Landing Light Cover Panel. Reinstall the Landing Light Cover Panel by reinstallation of the Bell P/N 120-225C3T-15 fasteners. Torque to 12 – 15 in-lb.

To reinstall the AFM-NM429-1 Nose Mount, remove the Landing Light Cover Panel, apply the 3M tape (or A2008 Protective Cloth) to mating surfaces between the Panel and the Mount, and reinstall the panel and Nose Mount together. Install using the Bell P/N 120-225C3T-15 fasteners. Torque to 12-15 in-lb.


